

SERVICE RATES SCHEDULES**2024****PART I GENERAL PROVISIONS & DEFINITIONS****[a] Belview Port - Vehicle Parking**

Vehicles may only park at Belview Port in designated areas

Unauthorised vehicles will be clamped and/or removed at the owners' expense.

[b] Provision of Fresh Water

Fresh Water to ships must be ordered in advance

[c] Belview Port - Uncovered Storage

Ground Storage of goods at Belview Port shall only take place with the express permission of the Harbour Master, or appointed Deputy

[d] Payment of Dues

Fresh Water Dues shall be paid by the master, owner or agent of the vessel in respect of which such dues are charged.

[e] Recovery of Dues

If any vessel's master, owner or agent evades or attempts to evade payment of harbour charges, he/she shall be subject to the provisions of Section 14 of the Harbour Act, 1996, "Detention and sale of ship or goods for unpaid harbour charges".

[f] Vessel Bunkering

No bunkering of vessels shall take place at Belview without the prior notification to the Port of Waterford and approval of the Harbour Master.
